



# 2010 T.A.A.F. MEN'S CLASS D STATE CHAMPIONSHIP



*"The Original State Championship of Texas"*

- Date:** June 26, 2010
- Entry Fee:** \$175 per team (cashier's check, money order - Payable to Dallas-TAAF).
- Eligibility:** **Must be TAAF registered.** If not already registered TAAF, you can register with your local Park & Rec or can register at the tournament. TAAF team registration is an additional \$10 fee.
- Entry Reimbursement:** TAAF is **reimbursing the entry fee for one team** from each TAAF Region (e.g. Dallas is Region 13). Check with your local Park & Rec Dept for more details on registering TAAF and possibly earning a "free" entry.

- Entry Deadline:** **Wed., June 23 – 5:00 p.m. Rosters must be included with entry.** (TAAF City Representative guarantee for payment will be accepted if guarantee is made by the entry deadline).
- Brackets:** Bracket will be available after 2:00 p.m. on Thursday, June 24 (will be posted on [www.quickscores.com](http://www.quickscores.com) )
- Softballs:** Provided by TAAF
- Playing Rules:** All games will be played under **2010 ASA Rules** (with TAAF exceptions). Teams must wear like-colored jerseys with 6" permanent number on back.
- Awards:** 1<sup>st</sup>-4<sup>th</sup> team trophies; 1<sup>st</sup>-2<sup>nd</sup> tees; MVP & All-Tournament plaques
- Advancement:** Champions will be awarded a **PAID** berth to the ASA Men's D South National Championship Tournament in Dallas on Sept. 4 – 5, 2010. ***All teams entered will qualify for the ASA National Championship.***
