MANAGER'S MEETING: Mandatory Coaches Meeting Friday, March 1, 6:00-7:00pm at Barnett Junior High School, 2101 E Sublett Rd, Arlington, TX 76018). All teams must have a representative present. All teams must have all rosters/birth certificates and fees turned in prior to coaches meeting by **February 26<sup>th</sup>**.

GAME TIMES: Teams should be prepared to play on Friday, March 1 after the coaches meeting based on the bracket.

UNIFORMS: Each team must provide their own set of uniforms with permanently fixed numbers on the front and back per the TAAF Cavalcade.

EQUIPMENT: The official game ball will be provided. Teams must provide their own warm-up equipment.
